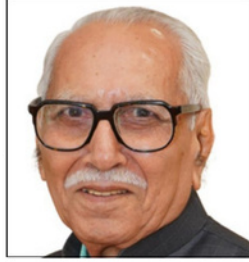




DESK OF PRESIDENT

Deepening Understanding: Dharma Charcha – 18 Papsthanak Series 2025

Organized In Collaboration with JAS, Ahmedabad | 5th November 2025



JCAF marked a meaningful milestone with the launch of its first-ever topic-based Dharma Charcha series, conducted in collaboration with JAS (Jain Academy of Scholars), Ahmedabad. JAS is a respected global forum known for its scholarly work in Jain philosophy, scientific validation of Jain concepts, and promoting their practical application in daily life.

The inaugural session, led by the renowned Dr. Bipin Doshi, began with a thoughtful exploration of the meaning of Dharma across various religions. He then shifted to Jain philosophy, explaining the concepts of Dharma, Punya, and Paap, followed by an insightful introduction to the 18 Papsthanak.

For the first time, JCAF is presenting a series of Dharma Charcha sessions on a single theme, with this initiative strengthened further through JAS's participation. Their scholars also joined the post-lecture discussions, adding depth and scholarly perspective to the Q&A.

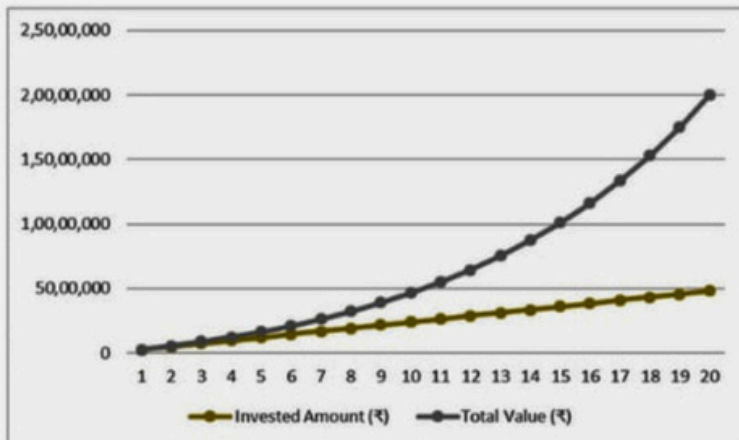

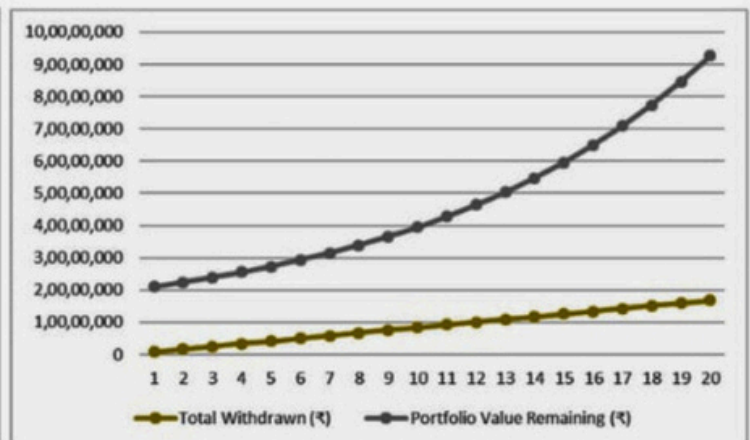

97th Blood Drive: A Contribution to Humanity

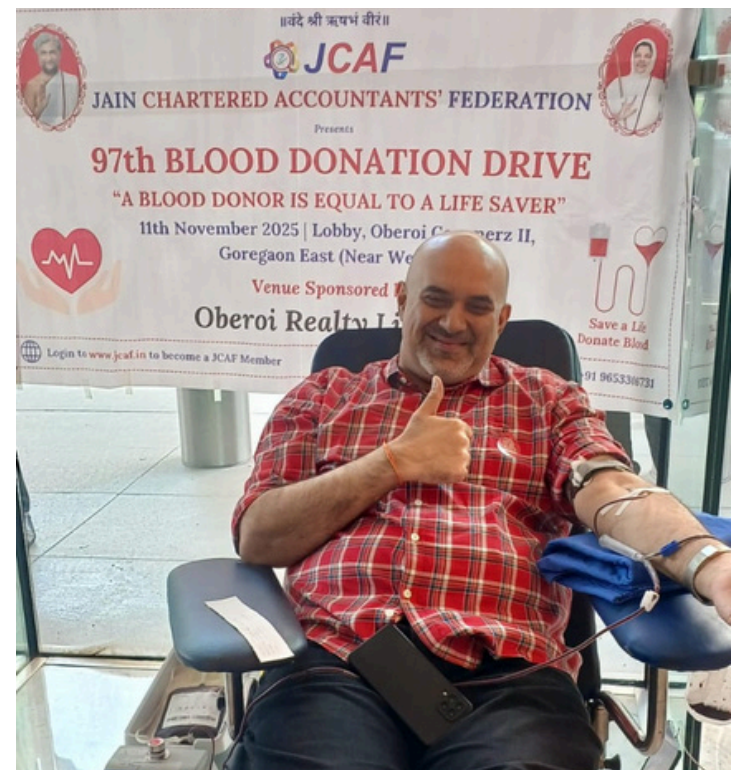

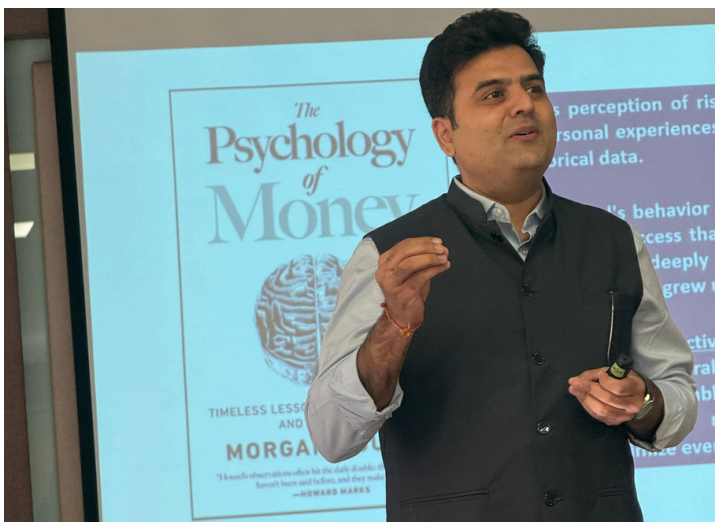
